Authorization of transaction: novellas adopted and required

The article deals with the theory of law enforcement practice, and it shows the necessity to distinguish between acceptance of transaction (expressed by a party to a civil transaction), transaction authorization (by a public body), and transaction approval (by a corporate body). The author proposes to introduce a norm which will oblige the counter party to enquire about availability of transaction authorization required under the law or constituent documents; the counter party will also be required to determine a provisional term for the validity of the transaction authorization which will be one year.
